AN ACT RELATING TO REDISTRICTING THE HOUSE OF
REPRESENTATIVES

The Senate proposes to the House to amend the bill as follows:

First: In Sec. 1, on page 7, by striking out lines 5 through 20, by striking out all of pages 8 through 11, and on page 12, by striking out lines 1 through 16, and by inserting in lieu thereof the following:
